

# Promoting Forest Stewardship Through Education

#### Winter 2024

## A YEAR IN FORESTRY EDUCATION









We concluded another year of forestry education reaching a variety of audiences in 2023—from elementary students all the way to high school classes and college students. In total, we reached 3,105 people with our programs designed to educate about forests and inspire an appreciation for the many benefits of working forests. Forest Field Days alone reached about 1,326 middle school students, with 158 teachers and chaperones learning alongside students in the field. We served 836 4th and 5th graders with tree farm field trips, a new program that brings younger students to the tree farm to experience a working forest while learning about trees, forest fire, protecting water, and more. High school programs collectively reached 526 students. The forest fire program was delivered to 12 classes and the forest careers program reached 11 classes. We engaged an additional 84 high school students from Eugene 4J's CTE program in Forestry and Natural Resources, offering them hands-on experiences in forestry and connecting them with professionals who work in the field. At the college level, we reached 31 University of Oregon History students with a tree farm tour to help explore the role of forestry in the broader history of the Pacific Northwest. We reached 20 additional college-age individuals with a training provided to the staff at Camp Lutherwood where we taught new summer staff about forestry to complement and help develop their outdoor education programming. We are proud of our accomplishments in 2023 and look forward to the year ahead with the intent of continuing and growing our important work in forestry education. Of course, we owe our success to the many supporters listed on the next page who provide generous financial support, to the hundreds of volunteers who donate their time and expertise to teach during our programs, and to landowners, Tom Bauman and Lindsay Reaves, who partner with us to provide field experiences to the public.

## THIRTY YEARS OF FOREST FIELD DAYS!

2024 marks 30 years of Forest Field Days by Forests Today & Forever (FTF). The program was originally created by the Corvallis School District, Benton County, OSU Extension, and the Mary's Peak Chapter of the Society of American Foresters. When Forests Today & Forever observed the program, board members were impressed with its reallife introduction to forest management with its emphasis on choice, compromise, and responsibility. In 1994, FTF enthusiastically launched the program in Lane County as a mission-oriented initiative to promote forest stewardship through education. The first year was implemented in partnership with Springfield Public Schools and 876 students attended. Since then, the program has run continuously (except for two seasons during the COVID pandemic) and has served an estimated 58,000 students from over 30 schools and 12 school districts. Forest Field Days has withstood the test of time, as the curriculum framework is much the same today as it was in 1994. While there have been some updates to program content to align with educational standards, the original approach—as a thought-provoking and interactive introduction to forests and forest management—remains intact. With this strong foundation, we are excited to bring Forest Field Days into the future. Accordingly, we

are embarking on a thorough review and update to our curriculum in 2024 to ensure that we are teaching the most important and relevant topics while strengthening our ties to educational standards. We look forward to presenting a modernized Forest Field Day program that maintains the original framework while incorporating content that is current, relevant, and tailored to today's student audience.


